# Understanding

Autism spectrum disorder (ASD) is a developmental disability that can cause significant social, communication and behavioral challenges. There is often nothing about how people with ASD look that sets them apart from other people, but people with ASD may communicate, interact, behave, and learn in ways that are different from most other people. The learning, thinking, and problem-solving abilities of people with ASD can range from gifted to severely challenged. Some people with ASD need a lot of help in their daily lives; others need less.

## Autism Spectrum Disorder (ASD) is characterized by:




- Ongoing social problems that include difficulty communicating and interacting with others
  - Repetitive behaviors as well as limited interests or activities
  - Symptoms that typically are recognized in the first two years of life
- Symptoms that hurt the individual's ability to function socially, at school or work, or other areas of life.
  - People with ASD may also experience sleep problems and irritability.

Although people with ASD experience many challenges, they may also have Strengths, including:

- Being able to learn things in detail and remember information for long periods of time
- Being strong visual and auditory learners
- Excelling in math, science, music, or art.

Prevalence The Centers for Disease Control and Prevention (CDC) estimates autism's prevalence as 1 in 59 children in the United States.

Today, autism is the fastest-growing serious developmental disability in the U.S., and is estimated to affect more than 3 million individuals in the U.S.

## Tackling autism with evidence-based treatment.

What does it mean to be an evidence-based treatment? "Evidence-based" means that the treatment has passed scientific tests of its usefulness, quality, and effectiveness. The method of treatment used here at the Comprehensive Learning Center is known as Applied Behavior Analysis (ABA).

ABA is a scientific discipline concerned with applying techniques based upon the principles of learning to change behavior of social significance. ABA for autism intervention includes many different techniques focusing on antecedents (what happens before a behavior occurs) and on consequences (what happens after the behavior).

### Why do we use ABA?

ABA is considered an evidence-based, best practice treatment by the US Surgeon General and by the American Psychological Association. More than 20 studies have established that intensive and long-term therapy using ABA principles improves outcomes for many but not all children with autism. "Intensive" and "long-term" refer to programs that provide 25 to 40 hours a week of therapy for 1 to 3 years. These studies show gains in intellectual functioning, language development, daily living skills and social functioning. Studies with adults, though fewer in number, show similar benefits.

#### Studies have shown...

- ABA is effective in teaching new skills
- ABA is effective in reducing challenging behavior
- When implemented intensively (more than 20 hours per week) and early in life (beginning prior to the age of 4 years), ABA may produce large gains in development and reductions in the need for special services; however, large studies with strong experimental designs are needed to confirm the results reported for intensive, early intervention.

With the rise of individuals being diagnosed with Autism, there comes a rise in cost for services meeting the needs of this population.

The projected cost to society by 2025 is estimated to reach \$1 Trillion annually




